# 1. BID SUBMISSION:

- 1.2. ALL BIDS MUST BE SUBMITTED ON THE OFFICIAL FORMS PROVIDED—(NOT TO BE RE-TYPED) OR IN THE MANNER PRESCRIBED IN THE BID DOCUMENT.
- 1.3. THIS BID IS SUBJECT TO THE PREFERENTIAL PROCUREMENT POLICY FRAMEWORK ACT, 2000 AND THE PREFERENTIAL PROCUREMENT REGULATIONS, 2017, THE GENERAL CONDITIONS OF CONTRACT (GCC) AND, IF APPLICABLE, ANY OTHER SPECIAL CONDITIONS OF CONTRACT.

### **Conditions of Bid**

#### 1. OFFER AND SPECIAL CONDITIONS

- 1.1 Without detracting from the generality of clause below, bidders must submit a completed and signed Invitation to Bid form (SBD 1) with its bid. Bidders must take careful note of the special conditions.
- 1.2 <u>All bids submitted in reply to this invitation to bid should incorporate all the forms,</u> parts, certificates and other documentation forming part of this invitation to bid, duly completed where required.
- 1.3 In the event that any form or certificate provided in Part 3 of this invitation to bid does not have adequate space for the bidder to provide the requested details, the bidder should attach an annexure to such form or certificate on which the requested details should be provided and the bidder should refer to such annexure in the form or certificate provided.

#### 2. CLOSING TIME OF BIDS AND PROVISIONS RELATING TO SUBMISSION OF BIDS

- 2.1 The closing time for the receipt of bids in response to this invitation to bid is detailed on the cover page of this invitation to bid.
- 2.2 All bids must be submitted in a sealed envelope bearing the bid number, bid description and closing date.
- 2.4 All bids must be received before the closing time and date stipulated above and must be posted to or deposited in the bid box at the address detailed on the cover page of this invitation to bid.

#### 3. ENQUIRIES

Should any bidder have any enquiries relating to this invitation to bid, such inquiries may only be addressed to the person/s detailed on the cover page to this invitation to bid at the number/s stipulated.

There will be no site visit and briefing session for this bid

#### 5. PRICING

- 5.1 The bidder must submit details regarding the bid price for the Services on the <u>SBD 3.1</u> which must completed and submitted together with the bid documents.
- 5.2 Pricing must be stipulated INCLUSIVE OF VALUE ADDED TAX.
- 5.3 It is an express requirement of this invitation to bid that the bidders provide some transparency in respect to their pricing approach. In this regard, bidders must indicate the basis on which they have calculated their pricing by completing all aspects of the Pricing form <a href="SBD3.1">SBD3.1</a>

#### 6. DECLARATION OF INTEREST

The bidder should submit a duly signed declaration of interest (SBD 4) together with the bid. The declaration of interest is attached as SBD4

#### 7. DECLARATION OF BIDDER'S PAST SUPPLY CHAIN MANAGEMENT PRACTICES

#### 8. CERTIFICATE OF INDEPENDENT BID DETERMINATION

The bidder must complete the certificate of bid determination and sign accordingly to submit with the bid. The declaration of bidder's past supply chain management practices is attached as SBD9

#### 9. PREFERENCE POINTS CLAIM FORMS

<u>SBD 6.1</u> contains the Preference Points Claim Forms in terms of Preferential Procurement Regulations to be completed and signed by the bidder to the extent applicable and returned with this bid.

#### 10. VALIDITY

Bid documentation submitted by the bidder will be valid and open for acceptance for a period of 60 (Sixty) calendar days from the closing date and time stipulated on the front cover of this invitation to bid.

#### 11. ACCEPTANCE OF BIDS

The DoH does not bind itself to accept either the lowest or any other bid and reserves the right to accept the bid which it deems to be in the best interest of the DOH even if it implies a waiver by department of certain requirements which the DoH considers to be of minor importance and not complied with by the bidder.

#### 12. NO RIGHTS OR CLAIMS

- 12.1 Receipt of the invitation to bid does not confer any right on any party in respect of the Services or in respect of or against the DoH. The DoH reserves the right, in its sole discretion, to withdraw by notice to bidders any Services or combination of Services from the bid process, to terminate any party's participation in the bid process or to accept or reject any response to this invitation to bid on notice to the bidders without liability to any party. Accordingly, parties have no rights, expressed or implied, with respect to any of the Services as a result of their participation in the bid process.
- 12.2 Neither the DoH, nor any of their respective directors, officers, employees, agents, representatives or advisors will assume any obligations for any costs or expenses incurred by any party in or associated with any appraisal and/or investigation relating to this invitation to bid or the subsequent submission of a bid in response to this invitation to bid in respect of the Services or any other costs, expenses or liabilities of whatsoever nature and howsoever incurred by bidders in connection with or arising out of the bid process.

### 13. NON DISCLOSURE, CONFIDENTIALITY AND SECURITY

- 13.1 The invitation to bid and its contents are made available on condition that they are used in connection with the bid process set out in the invitation to bid and for no other purpose. All information pertaining to this invitation to bid and its contents shall be regarded as restricted and divulged on a "need to know" bases with the approval of the DoH.
- 13.2 In the event that the bidder is appointed pursuant to this invitation to bid such bidder may be subject to security clearance prior to commencement of the Services.

#### 14. ACCURACY OF INFORMATION

- 14.1 The information contained in the invitation to bid has been prepared in good faith. Neither the DoH nor any of their respective directors, advisors, officers, employees, agents, representatives make any representation or warranty or give any undertaking express or implied, or accept any responsibility or liability whatsoever, as to the contents, accuracy or completeness of the information contained in the invitation to bid, or any other written or oral information made available in connection with the bid and nothing contained herein is, or shall be relied upon as a promise or representation, whether as to the past or the future.
- 14.2 This invitation to bid may not contain all the information that may be required to evaluate a possible submission of a response to this invitation to bid. The bidder should conduct its own independent analysis of the operations to the extent required to enable it to respond to this bid.

#### 15. COMPETITION

- 15.1 Bidders and their respective officers, employees and agents are prohibited from engaging in any collusive action with respect to the biding process which serves to limit competition amongst bidders.
- 15.2 In general, the attention of bidders is drawn to Section 4(1)(iii) of the Competition Act1998 (Act No. 89 of 1998) (the Competition Act) that prohibits collusive biding.
- 15.3 If bidders have reason to believe that competition issues may arise from any submission of a response to this bid invitation they may make, they are encouraged to discuss their position with the competition authorities before submitting response.
- 15.4 Any correspondence or process of any kind between bidders and the competition authorities must be documented in the responses to this invitation to bid.

#### 16. RESERVATION OF RIGHTS

- 16.1 Without limitation to any other rights of the DoH (whether otherwise reserved in this invitation to bid or under law), the DoH expressly reserves the right to:-
- 16.2 Request clarification on any aspect of a response to this invitation to bid received from the bidder, such requests and the responses to be in writing;

- 16.3 Amend the bidding process, including the timetables, closing date and any other date at its sole discretion;
- 16.4 Reject all responses submitted by bidders and to embark on a new bid process.
- 16.5 Award the bid to one or more than one bidder/s.

#### 17. EVALUATION CRITERIA

The bid will be evaluated in terms of the 80/20 point system as stipulated in the Revised Preferential Procurement Regulations, 2017. 80 points will be allocated for price and 20 points for attaining the B-BBEE status level of contributor.

Where

Ps = points scored for comparative price of bid or offer under consideration.

Pt =Comparative price of bid or offer under consideration.

Pmin = comparative price of lowest acceptable bid or offer.

**NB**: Bidders are required to, together with their bids submit original and valid B-BBEE status level verification certificates *issued by SANAS accredited agent* or certified copies or Sworn Affidavit in the case of Emerging Micro Enterprise (EME) and Qualifying Small Enterprise (QSE) to substantiate their B-BBEE rating claims.

A bid will not be disqualified from the bidding process if the bidder does not submit a certificate substantiating the B-BBEE status level of contribution or is a non-compliant contributor. Such a bidder will score 0 out of maximum of 20 points for B-BBEE

This initiative has been implemented with a view of ensuring that Eastern Cape Communities get vaccinated with WHO standardized protocols not being compromised during the 1<sup>st</sup> Phase roll-out Program.

Due to the outcome of the assessment it has come to the attention of Supply Chain Management that a total of \_\_\_200\_\_\_ WHO pre-approved Cooler Boxes will be purchased in various sizes as per the requirements of the End Users.

The Department reserves the right to award one and or more than one Service Provider for these Cold Storage Commodities.

- Hinges, where fitted, must allow the lid to open beyond 90° to give full access to the interior of the cooler box. Hinges must be maintenance-free, without need for lubrication and must be secured to the container in a manner which prevents loosening due to vibration.
- Carrying device must be robust and firmly attached in order to survive rough handling. Can be a hinged, sliding or molded handle attached to the cooler box or lid. When folded away, the moveable handles must not extend beyond the vaccine cooler box. The handle arrangement must not prevent the stable stacking of the content.
- All metallic components and their fixing must be corrosion resistance.
- The internal and external surfaces of the cooler box must be resistant to chemicals used for disinfecting.
- All parts must be water and vapour proof, must resist UV degradation, easy to clean and must be selected with environmentally safe end of life disposal in mind.
- Must be covered by a 2-year replacement warranty in case of any component failure arising from defective design, materials or workmanship.
- Must be maintenance free apart from cleaning.
- The internal dimensions of the cooler box must be compatible with any of the standard water packs they are supplied with.
