6. PRICING

Accordingly, parties have no rights, expressed or implied, with respect to any of the Services as a result of their participation in the bid process.

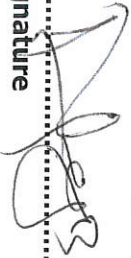
