



Radiology personnel are expected to ensure that they monitor the functioning of the X-Ray equipment by carrying out quality checks on a weekly and monthly basis. This information needs to be continuously accessed by the Radiology personnel due to the dynamic status of the technology. Over and above it is a compliance issue and if quality checks are not consistently done accordingly, Radiation control inspectors close down the department or use of such X ray machines.

Additional conditions to the prospective bidders.

The successful bidder must:





24. COMPETITION

EVALUATION CRITERIA

26.1 The bid will be evaluated as follows:

- Stage 1: Administrative compliance /pre-qualification
- Stage 2: Functionality
- Stage 3: Price and B-BBEE Points

The stages are further detailed below

26.2 In terms of Regulation 6 of the Preferential Procurement Regulations pertaining to the Preferential Procurement Policy Act (Act 5 of 2000), responsive bids will be adjudicated by the department on the 80/20- preference points system in terms of which points are awarded to bidders on the basis of:

- The bid price (maximum 80 points)
- B-BBEE status level of contributor (maximum 20 points)

The following formula will be used to calculate the points for price:

or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.






- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). 

- (b) if the Supplier fails to perform any other obligation(s) under the contract; or

Organizational structure


