#### **RETURNABLE SCHEDULE 3: CONDITIONS OF CONTRACT & OPERATIONAL REQUIREMENTS**

#### 1. CONTRACT

The contract for the rendering of the required Service in terms of this invitation to QUOTE shall come into being on the date of issue of the letter of acceptance of the QUOTE by the Eastern Cape Department of Health (Nelson Mandela Academic Hospital) and shall continue in force for a period of 12 months. The Supplier is further obliged for the future support while the contract is in force.

- 2. FEES AND CHARGES
- 2.1 Prices shall be firm for the first 2 months.
- 2.2 Payment of any consideration in terms of the contract shall not constitute acceptance of any defective or non-conforming Services or otherwise relieve contractor of any of its obligations under the contract.
- 2.3 To the extent that the Nelson Mandela Academic Hospital disputes the correctness, nature, extent or calculation of any fees or expenses payable to contractor in terms of the contract, Nelson Mandela Academic Hospital shall be entitled to withhold payment of such disputed amounts until such time as such dispute is resolved.
- 3. GENERAL RESPONSIBILITIES OF THE CONTRACTOR
- 3.1 The contractor is expected to adhere to a service call as follows; -
- 3.1.1 Emergency within 3 hours
- 3.1.2 Normal preventative within 24 hours

- 3.2 The Nelson Mandela Academic Hospital's operational requirements. The contractor shall, in the provision of the required service, have due regard to the operational requirements of the Nelson Mandela Academic Hospital and other parties occupying or operating from the relevant institution, and shall not do, or permit to be done, anything which may negatively impact on such parties' operational requirements.
- 3.3 Problem identification and reporting. The contractor shall be proactive in reporting any matters which it may become aware of which may impact on the business continuity or operations of the Nelson Mandela Academic Hospital.
- 3.4 Other Service Providers The contractor acknowledges that it may be required to provide the Services in conjunction with third party service providers and shall, where requested by the Nelson Mandela Academic Hospital, co-operate fully with such persons.
- 3.5 Regulations and statutes the contractor shall, in the provision of the Services observe and comply with all relevant provisions of all applicable legislation and regulations.
- 3.6 Compliance with procedures. It is recorded that during the currency of the contract the Nelson Mandela Academic Hospital may implement procedures and policies at the relevant Institution. The contractor shall comply fully with any such reasonable procedures and policies, including the permit to work procedures and health and safety procedures.
- 3.7 The contractor shall ensure that it and its personnel shall at all times fully comply with any safety, fire, emergency and security procedures and policies applicable at the relevant Institution.
- 3.8 Should the Nelson Mandela Academic Hospital at any time believe that any member of contractor's personnel is failing to comply with any such procedures or policies, the Nelson Mandela Academic Hospital shall be entitled to deny such staff member access to the relevant premises and require contractor to replace such person without delay.
- 3.9 Contractor's procedures The contractor shall, upon receipt of written request from the Nelson Mandela Academic Hospital or its appointed Technical Support Manager at the relevant Institution Provide the Nelson Mandela Academic Hospital with copies of all contractor's operating procedures and processes relating to the Services;
- **3.10 Provision of Services in clean and tidy manner.** The contractor shall ensure that the Services are provided in a clean and tidy manner.
- 3.11 Service reports: The contractor shall, upon written request from the DOH or its appointed Nelson Mandela Academic Hospital Manager, provide the DOH with such reports relating to the Service as may be stipulated in the Specifications, or as may be reasonably required by the DOH or its appointed Nelson Mandela Academic Hospital Manager to determine whether contractor is providing the Services in accordance with the terms and conditions of the contract.

## 4. HAZARDOUS MATERIALS

The contractor will be held liable for any expenses that may be incurred by the NELSON MANDELA ACADEMIC HOSPITAL as a result of damage to property and injury to personnel as a result of poor quality products.

#### 5. FIRE RISKS

The contractor shall ensure that its personnel shall, if at any time they believe that any matter constitutes a fire risk, report this immediately to the Nelson Mandela Academic Hospital/Institution and take such remedial action as may be necessary.

#### 6. ENERGY MANAGEMENT

The contractor shall comply fully with the energy management strategy implemented at the relevant Institution from time to time and shall provide the Services in an energy efficient manner.

#### 7. OCCUPATIONAL HEALTH AND SAFETY

In this clause the term "Act" shall mean the Occupational Health & Safety Act, No. 85 of 1993, as amended from time to time, (including any act which may take its place should it be repealed during the currency of the agreement between the parties) as read with all regulations and standards promulgated in terms of the former Machinery and Occupational Act, no 6 of 1983, as amended, and all regulations & standards promulgated in terms of the Occupational Health & Safety Act from time to time;

#### The contractor: -

- acknowledges that he is fully aware of the terms and conditions of the Act;
- acknowledges that he is an employer in its own right with duties and responsibilities as prescribed in the Act;
- agrees to comply with all rules and regulations implemented by or on behalf of the Nelson Mandela Academic Hospital at the relevant Institution in covering letter relating to health and safety and will inform the Nelson Mandela Academic Hospital immediately should contractor for any reason be unable to comply with the provisions of the Act and such rules and regulations.

#### 8. SERVICE LEVEL AGREEMENT

It is recorded that the Nelson Mandela Academic Hospital and the service provider may from time to time agree in writing to additional quality requirements (whether engaged in a service contract or when repair is required out of guarantee without the maintenance contract option) and standards relating to the maintenance together with performance measurement provisions, which quality requirements, performance measurement provisions shall be reduced to writing in a service level agreement if required and signed by both parties.

## 9. PERFORMANCE MEASUREMENT PROVISIONS

#### 9.1 Introduction.

Contractor shall provide the Services during the term of the contract in compliance with the quality and related standards stipulated in the Specifications, QUOTE Conditions and the service level agreement (if any) contemplated in clause 11 of this document.

The provisions of Clause 10 document contain the manner in which contractor's performance will be measured throughout the term of the contract.

**9.2 Compliance.** For purposes of the contract the compliance by contractor with the stipulated responsibilities and service standards will be determined: -

- with reference to reports provided by contractor (inclusive of before and after photographs clearly indicating work performed);
- with reference to reports or complaints received from third parties;
- by means of user satisfaction surveys conducted by Nelson Mandela Academic Hospital
- by means of service reviews, inspections or any audit carried out by or on behalf of the Nelson Mandela Academic Hospital.
- 9.3 Records. Contractor shall at all times keep full and accurate records of all Services provided in terms of the contract and shall retain such records for the currency of the contract. Upon termination of the contract such records must be provided to the Nelson Mandela Academic Hospital.

## 9.4 Measurement of performance

- Periodic checks: Nelson Mandela Academic Hospital and/or its appointed Technical Support Manager shall carry out periodic checks (the intervals to be determined by Nelson Mandela Academic Hospital) the purpose of which shall be to determine whether contractor is providing the Services in accordance with the terms and conditions of the contract if accepted by Nelson Mandela Academic Hospital.
- Service complaints: All service complaints, deviations, non-conforming services and suggestions that are reported to contractor by Nelson Mandela Academic Hospital, its appointed facilities manager, or any other party shall be given proper and speedy consideration by contractor. The Contractor shall investigate complaints, deviations and non-conforming services in accordance with procedures approved by the Nelson Mandela Academic Hospital.
- User satisfaction survey: A user satisfaction survey shall be conducted by Nelson Mandela Academic Hospital at such intervals as Nelson Mandela Academic Hospital may determine to assess service user satisfaction. The user satisfaction survey shall be conducted in such form and in accordance with such procedures as the parties may agree to in writing from time to time.
- 9.5 Results of checks, audits and surveys: Nelson Mandela Academic Hospital shall be entitled to utilize the findings of the surveys, checks, audits and reports contemplated above to determine compliance by contractor with the service standards and responsibilities stipulated in the contract. It is recorded that the results of the above checks shall, save to the extent that contractor can prove otherwise be binding on contractor and Nelson Mandela Academic Hospital shall be entitled to exercise its remedies stipulated in the contract based on such findings.

#### 10. BREACH AND TERMINATION

QUOTE are referred to Paragraph 23 of General Conditions of Contract (GCC) relating to failure to comply with conditions of this contract.

#### 11. LOSS AND DAMAGE

Contractor hereby indemnifies the State, and will hold the State harmless, against any loss or damages which the State may suffer, or any claims lodged against the State by any third party arising out of/or relating to any loss that the State or such third party may suffer as a result of/or arising out of any act or omission of any personnel of contractor or the failure of contractor to provide the Services in accordance with the provisions of the contract.

#### 12. SUB-CONTRACTORS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
  - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
