- 1.1 Without limitation to any other rights of the Eastern Cape Department of Health (ECDoH) (whether otherwise reserved in this invitation to bid or under law), the ECDoH expressly reserves the right to:-

2. EVALUATION CRITERIA

The bid will be evaluated in terms of Regulation 4(1) of the Preferential Procurement Regulation 80/20 Preference Point system will be applied where the lowest bidder will be allocated 80 Points for price. A maximum of 20 points will be awarded for specific goals.

The following formula will be used to calculate points out of 80 for price.

$$P_s = P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

P_s = points scored for comparative price of bid or offer under consideration.

P_t = Comparative price of bid or offer under consideration.

P_{\min} = comparative price of lowest acceptable bid or offer.

- a) A tenderer must submit proof of its Specific Goals.
- b) A tenderer failing to submit proof of specific Goals may not be disqualified, but may only score points out of 80 price, and scores 0 points out of 20 for Specific Goals.
- c) The Specific Goals supporting documents required to verify claimed points may in line with the specific requirements include:
 - CSD report (must be recent within 7 days from closing date):
 - CIPC Certificate and/or ID copies (must be certified with original stamp within 3 months from closing date of bid/quote):
 - Medical Certificate / Doctor’s medical report (Impairment should be substantially limiting long term or of recurring nature)
 - Municipal accounts or proof of address

The points scored for the specific goal shall be added to the points scored for price and the total shall be rounded off to the nearest two decimal places.

BID SPECIFICATIONS

The Department seeks to appoint a suitably qualified service provider to provide trained and experienced caregiver (s) as required.

6.1. The caregivers do not require a formal education or qualifications.

“Caregiver does not require a nursing qualification and would be a care giver or other person with required training in caring for a child with Cerebral Palsy, the training will be provided by the [Department]”.

It is preferable, however, that the caregivers have some experience in the care of children with significant physical and mental disabilities and / or cerebral palsy (“CP”).

6.2. The child’s caregivers will be required to perform the following tasks:

6.2.1. Establish a routine-based environment in which the child’s physical needs

are attended to and in which he can play and learn, taking into account his

impairments.

6.2.2. Attend to all of the child’s daily activities of living and needs, including:

6.2.2.1. Dressing;

6.2.2.2. Bathing;

6.2.2.3. Dental care;

6.2.2.4. Grooming;

6.2.2.5. Feeding (including management of PEG tube); and

6.2.2.6. Changing nappies.

6.2.3. Administer daily home-based programmes as advised by therapists including providing consistent sensory input and stimulation.

6.2.4. Incorporate basic therapeutic interventions into daily activities of living.

6.2.5. Turn him at night (typically every two hours) while he is sleeping to prevent pressure sores.

6.2.6. Apply splints and orthotics as prescribed.

6.2.7. Administer medications as prescribed.

6.2.8. Administer a posture-management routine as advised by therapists.

6.2.9. Accompany him to medical appointments and therapy sessions and communicate any treatment plans to other caregivers.

6.3. For practical purposes, the caregivers should have a driver's license or be willing to acquire a driver's license within a reasonable period from the date of their appointment.

- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
